Regulation of AI is coming at fast pace

Not only do AI systems perform poorly if the aspects mentioned above are ignored, but it can cause great financial and reputational damage. Therefore, organizations and regulators are seeking for measures that foster secure and responsible development and operation of AI. The proposal of the European Commission for an Artificial Intelligence Act (AIA) is currently top of the list. It is expected to have a similar impact as the General Data Protection Regulation (GDPR), with obligations including:

- the establishment of an AI-oriented risk management system,
- $\boldsymbol{\cdot}$ implementation of data governance measures,
- · creation of technical documentations and log management,
- transparency and information requirements and human oversight,
- measures for accuracy, robustness and cybersecurity.

Non-compliance with the AIA can have costly consequences, as fines can be up to 30 million Euro or 6% of a company's
