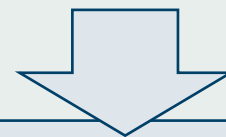
Unique features developed within **Protiviti ADA** can help internal control functions successfully overcome these limitations:

## Protiviti ADA at a glance

- Single point of access for end users
- Fully-developed GRC enhanced by data analytics

# How Protiviti ADA works

**ServiceNow IRM** provides:

- “One-stop-shop” for all data and action items regarding **process risks, controls, and tests** to verify control effectiveness
- **Test scripts** to trigger and then **collect test results** from Celonis (on demand or based on automatic scheduling)
- **Information flows** with control owners to request and monitor **corrective actions**
- **Dashboards** to **monitor** processes and internal control **performances** over time



**Seamless integration** allow users to jump from ServiceNow IRM interface to Celonis to **support further in-depth analysis** (process discovery feature)

**Celonis**, when triggered by ServiceNow:

- **Collects and scans transactional data** from different source systems to execute data analytics **tests** according to **scripts** and **parameters** set up within ServiceNow
- **Sends to ServiceNow test results** (% of non conformances and detailed list of anomalies)
- **Re-performs the test** (on the same scope included in the original run) to provide **insights about remediation progress**

## A unique combination of GRC and Advanced Analytics
