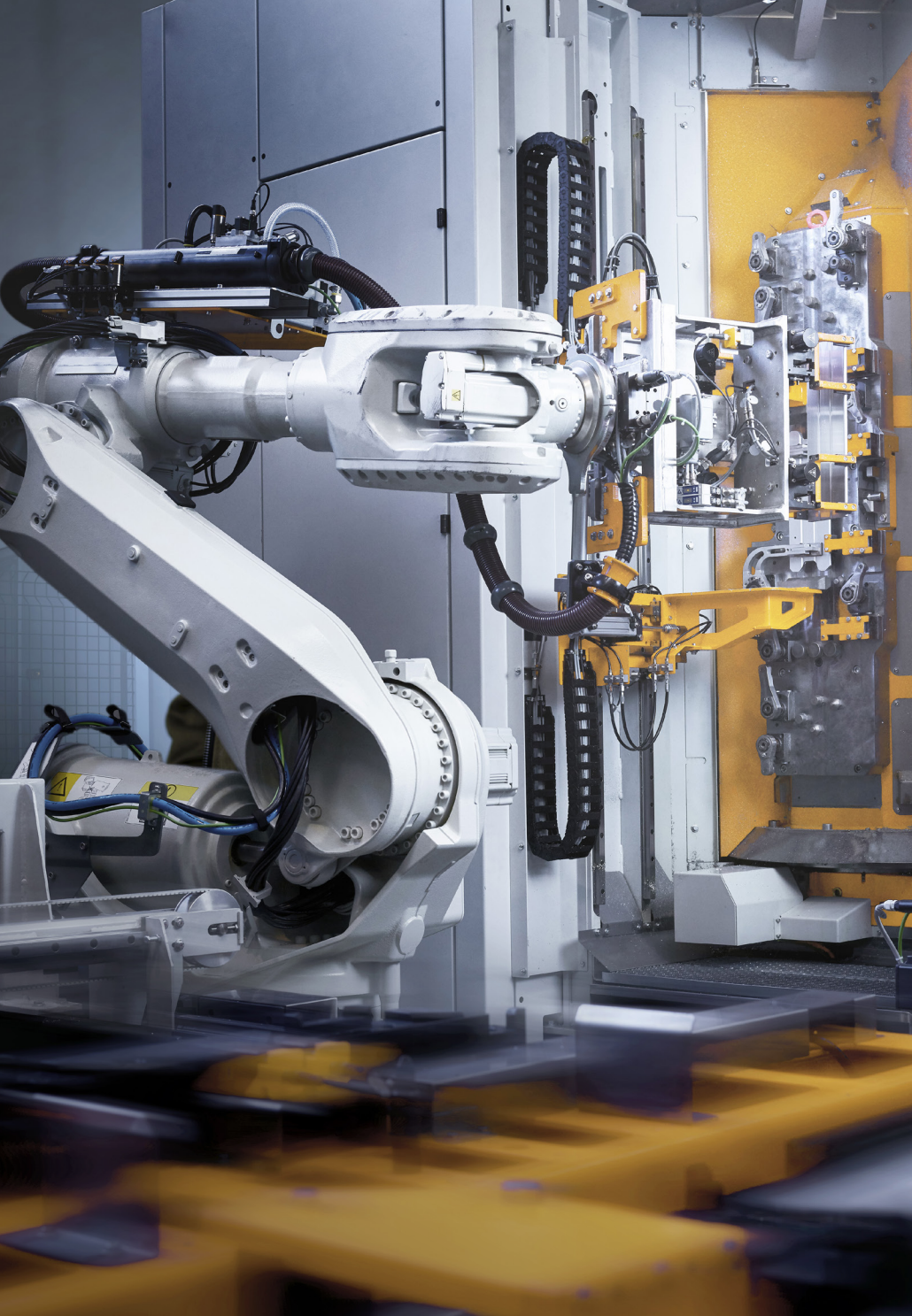

Accelerate access to analytics and insights to help teams make faster decisions, reduce reliance on multiple systems and support a more efficient and timely financial close.

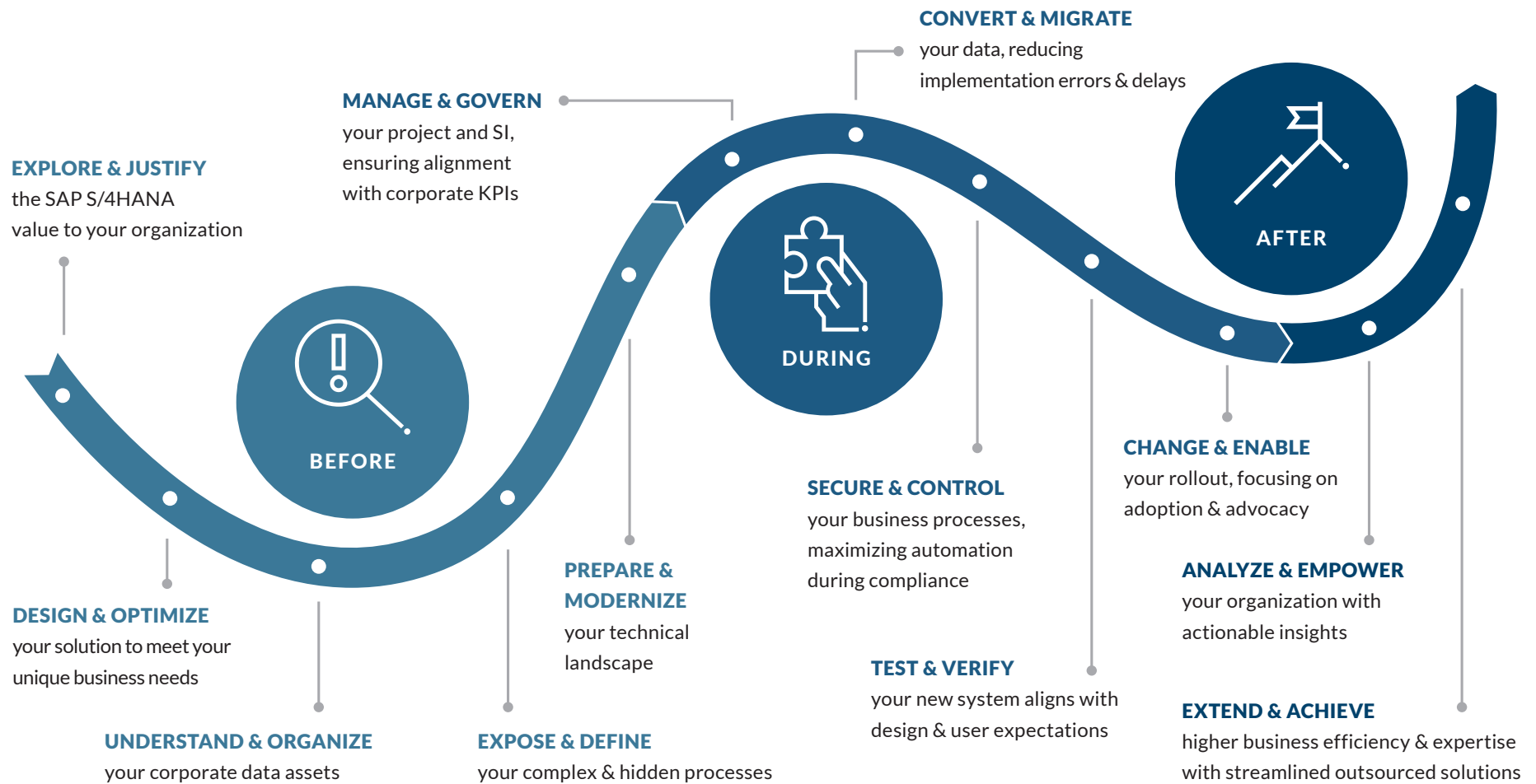
Enhance profitability analysis by leveraging built-in AI and unified profitability tools to assess margins across products, markets, channels, business units and customer segments.

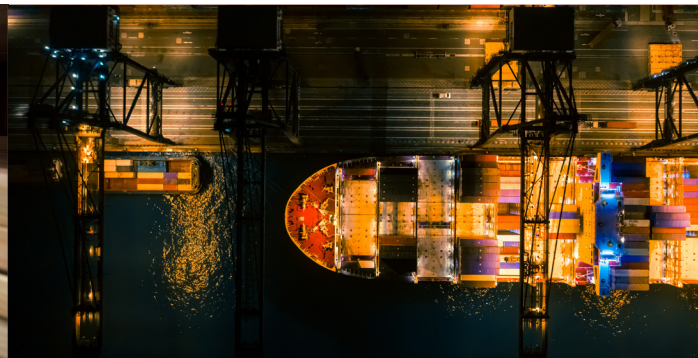

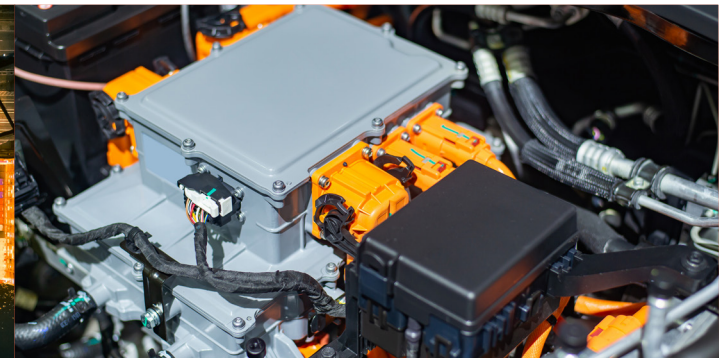
