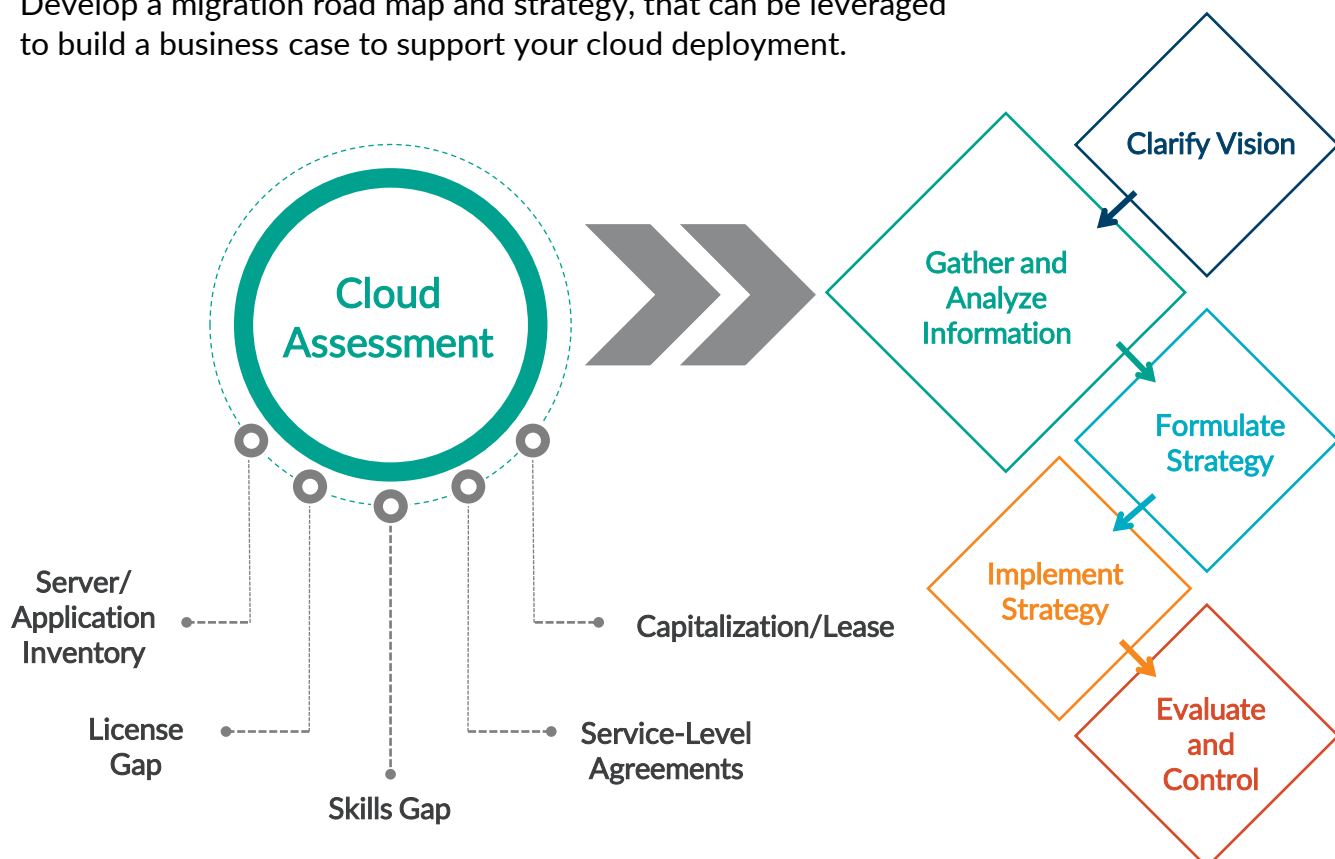

- Develop a migration road map and strategy, that can be leveraged to build a business case to support your cloud deployment.

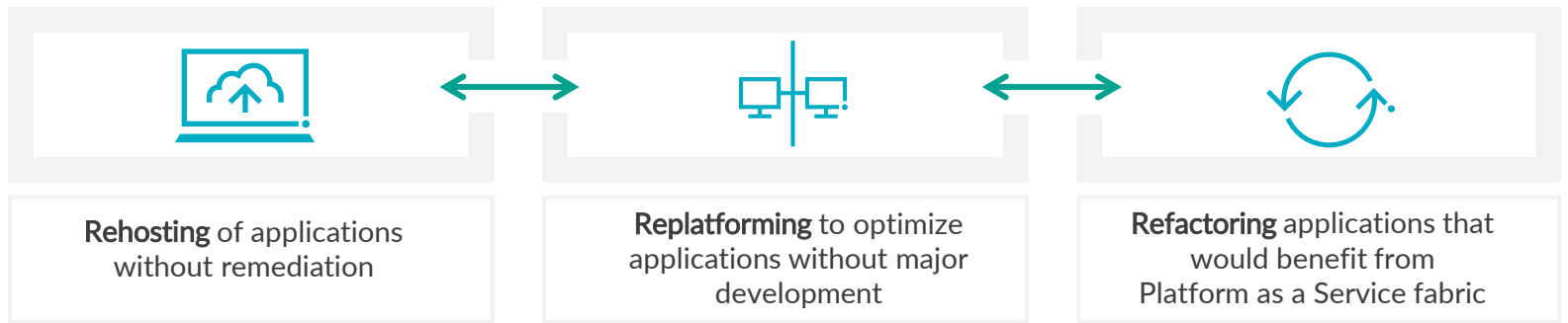

Three-Step Cloud Assessment

- 1 Discover**
Using cloud migration assessment tools, we compile an inventory of the physical and virtual servers in your environment. This data can include profile information and performance metrics about your applications. At the end of this step, you'll have a complete inventory of servers with metadata for each, allowing us to help you build your cloud migration plan.
- 2 Map on-premise applications**
Using information from the discovery phase, we will map servers to represent applications. This reveals dependencies or communication between servers for proper grouping in your cloud migration plan, which reduces risk and ensures a smooth migration. This allows us to help you identify the best migration strategy for each application based on its requirements and migration objectives.
- 3 Evaluate**
With your application groups mapped, we will evaluate how to best move each application using cloud migration assessment tools for cloud resource optimization. Evaluate the potential cost savings of migrating by calculating and comparing your total cost of ownership for cloud with that of a comparable on-premise infrastructure.
